CHAPTER-I

TENDER FOR PROVIDING STD/LOCAL/PHOTOCOPY/FAX AND INTERNET SERVICES AT DRONAGIRI RAIL TERMINAL

INSTRUCTIONS TO TENDERERS:

- Each applicant will submit his tender along with a demand draft for Rs.3,500/-(Rupees Three Thousand Five Hundred only) as earnest money payable to Container Corporation of India, Mumbai. Tenders received without the earnest money will be summarily rejected.
- 2. The last date for receipt of tender is **09/01/2020 upto 15:00 hrs.**
- 3. All tenders will be submitted in a sealed envelope in the office of Container Corporation of India Ltd., New Administrative Building, 5th Floor, D. N. Road, Central Railway Mumbai -CST, Mumbai 400 001. The sealed envelope containing the tenders must be superscribed as "Tenders for providing Std/Local/Photocopy/Fax and Internet services at Dronagiri Rail Terminal, DRT."
- 4. Tenders received will be opened in presence of representatives of the tenderers at 15:30 hrs on 09/01/2020 in Mumbai Regional Office, Container Corporation of India Ltd., New Administrative Building, 5th Floor, D. N. Road, Central Railway Mumbai CST. Mumbai 400 001.
- 5. Tenderers must visit the site of the **Dronagiri Rail Terminal**, **Dronagiri** and see for themselves the location of the STD booth. At present the area is approx 72 sq.ft.
- 6. It shall be understood that the tender document has been issued to the tenderer, and the tenderer is permitted to tender on the clear understanding that, after submission of this tender he will not rescind from his offer or modify the Terms and Conditions thereof in a manner not acceptable to CONCOR within 90 days of the tender opening date, unless extended further with mutual consent. Should the tenderer fail to observe or comply with the said stipulation by way of failure to execute an agreement or tenderer modifying/withdrawing the offer or refusing to accept work order or failing to furnish the requisites, the aforesaid amount in para 1 shall be liable to be forfeited to CONCOR.
- 7. The STD booth will be used predominantly by officials and visitors of CONCOR, Customs authorities, Shipping lines, Custom House Agents, Surveyors, Road Transportation companies other offices housed in the complex, Truckers, their staff and drivers of vehicles visiting the ICD/CFS.
- 8. The successful tenderers will be required to execute an agreement with CONCOR on stamped paper of requisite value as per the Annexure "B" of this document.
- 9. Allotment of licence will be done after all tenders received have been screened by a nominated Tender evaluation committee.

CHAPTER-II

Eligibility Conditions:

- a) Experience certificates in original/copy duly attested by Gazetted officer given by Organisation/Undertakings where the tenderer has provided similar nature of work during last one year.
- b) The tenderer should be registered with Shops & Establishment Act.
- c) The financial turnover of the tenderer should not be less than the Rs.40,000/-(Rupees Forty Thousand only) in its business (in the same name in which he is submitting his offer) during the financial year of 2018-19 (Audited P&L A/c, B/s or certificate from chartered accountant). Proof should be enclosed.
- The tenderer shall be required to deposit a sum of Rs.3,500/- (Rupees Three Thousand Five Hundred only) as Earnest Money. The earnest money shall be deposited only by crossed Demand Draft made-out in favour of "Container Corporation of India Ltd." payable at Mumbai and valid for a minimum period of six months from the date of issue. No tender will be accepted or considered without the remittance of Earnest Money Deposit. No interest shall be allowed on the earnest money deposited and also on security deposit as referred in the tender document. The earnest money deposited by the successful tenderer will be adjusted towards the security deposit. The earnest money of the unsuccessful tenderers will be returned as soon as possible after the tender has been finalised.
- e) The tenderer should enclose either the proof of ownership of two fax machines and two photocopy machines or submit a declaration to procure the same within 15 days from the date of award of contract and before taking the possession of the allotted space. All the machines should be in the name of the tenderer.

The Tender will not be considered unless the agency submits copies of proof of the above mentioned conditions.

f) The agency should enclose the copy of PAN No. and GSTN Registration number.

Note:

- 1. Tender document/ Sets shall be provided free of cost to Micro & Small Enterprises (MSE's) registered with the listed agencies.
- 2. MSEs registered with the agencies for the items tendered will be exempted from payment of Earnest Money Deposit (EMD).
- 3. MSEs who are interested in availing themselves of these benefits and preferential treatment, the MSEs will enclose with their offer the proof of their being MSE registered with any of the agencies mentioned in the notification of Ministry of MSME indicated below along with the bid.

- 4. The MSEs must also indicate the terminal validity date of their registration. (However, in those cases where the MSEs are not able to provide the certificate with validity date of their registration, a self-declaration by the MSE (Party) on their letter head, confirming the validity of their registration can be accepted.)
- 5. Failing (3) & (4) above, such offers will not be liable for consideration of benefits detailed in MSE notification of Government of India dated 23.03.2012.

CHAPTER-III TERMS AND CONDITIONS

1. **Duration of Contract**:

At the initial stage, this contract shall be awarded for a period of 2 (two) years from the date of possession of the premises and thereafter, CONCOR shall, however, have the right to exercise its discretion of extending the contract by 1 (one) more year at the same terms and conditions in case it considers it necessary. No request for any change in rates will be entertained during the initial currency of 2 years. However, the rates for extended period will be at the discretion of CONCOR, in case CONCOR decides to extend the contract. It is obligatory on the part of the contractor to continue to work at the rates prevailing on the last date of the contract and even beyond the contract period of 2 + 1 year for at least four months or till the new contract is finalized, whichever is earlier.

2. Exit Clause:

CONCOR will have the liberty to terminate the contract by giving an advance notice of (30) thirty days in case there are strong business reasons for it to do so as determined by its management. However, the agency has to run the business till the new agency is inducted in its place. The licensee shall vacate the licensed premises peacefully after the expiry of the contract or earlier if desired by CONCOR and shall hand over the same to the authorized officer. The licensee shall be free to remove without any damage to CONCOR property; the furniture, fitting and other articles as may have been brought by the licensee, at the end of his contract.

- 3. The licensee shall pay in advance by cheques the full amount of monthly license fee at the beginning of each month in the event of failure to pay the license fee and other dues on the stipulated date an interest @ 18% per annum will be charged beginning from the 1st day of month to which license fee pertains without prejudice to the other rights of licensor in addition the licensee shall also pay the electricity charges, water charges as per actuals. Licencee shall have to pay Rs. 300/- per month towards repairs & maintenance charges. The Contractor shall have to pay GST extra at the applicable rate.
- 4. Following facilities will require to be provided by the licensee at all times during the pendency of the contract. In case any facility is out of order or not working properly, license will require to arrange for substitute facility for smooth functioning.
 - a. STD facility : STD 1 No. to be arranged as per the direction of the

CONCOR.

b. LOCAL call facility: PCO 2 No.s to be arranged as per the direction of the

CONCOR.

c. FAX facility : Two Fax machines (With STD facility) to be installed as per

direction of CONCOR.

d. Photocopy facility: Two numbers machines to be installed as per direction of

CONCOR.

e. Internet Facility : One Personal Computer/Laptop(with printer attached to it)

with Internet facility.

5. The licensee will employ adequate number of staff in order to maintain efficiency to the standard desired by CONCOR and the customers.

All persons engaged by the licensee shall be treated as licensee's own employee and they will claim no privileges form CONCOR. The licensee will be directly responsible for the administration of his employees as regards their wages, uniforms, general discipline and courteous behaviour.

The licensee shall discharge from his/their service an employee who shall in the opinion of CONCOR misconduct's or is in any way unfit or unsuitable for the purpose of the business to be carried on in the said premises.

- 6. The licensee will be responsible for the cleanliness of area allocated.
- 7. All services shall be opened during office hours on all working days. The working hours will be specified by CONCOR. The services will remain closed on Sunday and other holidays unless specifically desired otherwise by CONCOR. In case the services are to be opened on holidays and kept open beyond office hours, CONCOR has the option to specifically direct the licensee to do so.
- 8. The licensee shall at his own cost effect, as required, as per the Act, necessary insurance in respect of the staff and other personnel or persons to be employed or engaged in connection with the rendering of the aforesaid services to CONCOR and shall comply with the provisions of all relevant Establishment Act of contract labour, Employees Staff Insurance Act, Workmen's Compensation Act, Payment of Wages Act, The Employee Provident Fund and Family Pension Fund Act 1952, the Payment of Bonus Act, Employees State Insurance if applicable, Provision of employment of Children Act of 1938, Hours of Employment regulations and any other rules, Regulation and /or statues that may be applicable to them now or that may be introduced by the Government, State Administration or Municipal Authorities subsequent to the date of this agreement and the Tenderer shall keep CONCOR indemnified form all acts of omission, default, breaches and /or any claim, demands, loss, injury and expenses to which CONCOR may be put to or involved as a result of Tenderers failure to fulfill any of the obligations hereunder and /or under statutes and/or any bylaws or rules framed there-under or any of them. CONCOR shall be entitled to recover any of such losses or expenses which it may have to suffer or incur on account of such claims, demands, loss or injury from monthly bills or from the security deposit of the licensee without prejudice to its any other rights under the law.
- 9. The licensee will have to furnish a monthly statement showing the names and wages of all the employees engaged and working in complex. Any addition/deletion must be communicated to CONCOR.
 - The licensee shall not in any capacity employ any persons of bad character or any persons whose antecedents have not been investigated by the police authorities and shall issue an appointment certificate which shall contain a photograph of the employee specifying the employee's name, father's name address and the place at which employed. The expenses for such verification to be borne by the licensee. The licensee shall not in any capacity employ any illiterate person in the premises allotted to him.

- 10. Any of the licensee's employees proceeding on leave shall immediately be replaced by the licensee so as to maintain satisfactory level of service at all times.
- 11. CONCOR shall have the right to search the licensee's employees at any time and there shall be no grievance expressed /felt on this account either by licensee or his employees. The licensee will issue ID cards to the worker in the format approved by CONCOR. Entry of employees into the ICD, Bonded Area and the Administration complex will be on basis of the identity cards only.
- 12. CONCOR shall authorize its official to inspect and over see functioning of services with a view to ensure efficient services. In case there are repeated failures of lacuna noticed due to failure of licensee, the authorised CONCOR official can impose a fine up to Rs. 1000/- at one time to be paid immediately by the licensee. The licensee will ensure that hazardous or inflammable or any other intoxicating material is not stored on the premises.
- 13. The licensee has to submit a **Security Deposit** equivalent to three months' license fee (As quoted by agency in Annexure "B") plus GST as per applicable rate, within 15 days from the date of issue of order/letter of intent. In the event of the security deposit or any portion thereof being forfeited appropriated supplied or used by CONCOR under the provisions of this agreement then the licensee will on demand provide further security in the place of the security forfeited appropriated or used as aforesaid so as to make up the security deposit to the amount required as aforesaid.
- 14. The licensee shall not sublet or assign the license or use the space provided for running the services for proposes other than running a STD/LOCAL/FAX/Photocopy/Internet services and shall not allow any body to reside in the licensed premises and shall not use the same or part of it for stocking or keeping articles other than those needed for use.
- 15. The licensee shall be responsible for all damages or losses to CONCOR property by the licensee or his staff and shall be liable to make good any such loss or damage immediately. Amounts claimed by CONCOR for such damages or losses shall be paid for by the licensee immediately on demand.
- 16. CONCOR will not be in any way responsible for any loss or damage accruing to any goods, stores or articles that may be kept by the licensee in the premises.
- 17. If the licensee shall die during continuance of this agreement, this agreement shall absolutely cease and determine and the heirs, executors or Administrators or other legal personal representatives of the said licensee shall have no interest whether under this agreement other than in respect of a claim for the return of the deposit money subject to provisions here in contained as to the same provided that nothing therein this clause contained shall be deemed to prejudice or effect any claim which CONCOR may have against such heirs executors or administrators or other legal personal representative for or in respect of any breach of any agreement by the said licensee here in contained during his/their life time or any right of indemnity CONCOR may have under and by virtue of the provisions of this agreement.

- 18. That the possession and control of DRT included the licensed premises shall be that of the licenser through out and it is clearly understood that the licensee shall not have any right to exclusive possession of the licensed premises at any time.
- 19. The rates of Telephone charges / Fax/ Xerox/Internet will be approved by CONCOR and the licence shall display in a conscious place the approved rate list of items and a complaint book for anyone to record complaints, and this book shall be open to inspection by persons duly authorised by CONCOR. The licence shall inform CONCOR Administration of the action taken by him in respect of complaints recorded in the book and shall carry out such directions as may be given to him by CONCOR from time to time.
- 20. Licencee shall install **Electrical meter** at its own expenses and pay electricity bill as per meter reading to CONCOR.
- 21. Licencee shall pay fixed charges of Rs. 300/- per month towards repairs & maintenance charges.
- 22. The offer should be accompanied in financial bid in "ANNEXURE-A"
- 23. CONCOR reserves the right to accept or reject any offer, without assigning any reasons thereof, and to amend the terms and conditions before award of the contract.
- 24. CONCOR reserves the right to appoint other agencies for providing same service in the same premises of DRT.
- 25. The tenderer will not have monopoly in the depot and will have to compete with other similar service providers.
- 26. In the event of repeated instances of unsatisfactory service or any failure at any time on the part of the contractor to comply with the terms and provisions of this contract to the satisfaction of CONCOR (who shall be the sole judge and whose decision shall be final), it shall also be open to CONCOR to terminate this contract by giving not less than (7) seven days' notice in writing to that effect and if the contractor, does not make good his default within the notice period, CONCOR shall be entitled to terminate the contract as a whole or in part.
 - In the event of such termination of the contract, CONCOR shall be entitled to:
 - (i) Forfeit the security deposit as it may consider fit;
 - (ii)Get the balance/remaining work done by making alternative arrangements as deemed necessary and until such time CONCOR is able to appoint a new regular Contractor; and recover from the contractor (appointed under this tender) any extra expenditure incurred by CONCOR in getting the work done and damages which CONCOR may sustain as a consequence of such action.

27. **ARBITRATION**:

In case of any dispute/difference arising out of the terms and conditions mentioned above, the same shall be referred to the CHIEF GENERAL MANAGER, Western Region, or any other officer nominated by him, who will act as arbitrator & whose decision shall be final. The fees and expenses of the arbitrator shall be shared equally between CONCOR and Other Party to the dispute i.e. vendor/supplier/ contractor.
