- 10. The contractor shall be required to pay cess @ 1% of cost of construction work in accordance with each bill payable on account of such construction to the <u>concerned State of Govt. (Labour Deptt.).</u> Cost of material shall be outside the purview of cess, when supplied under a separate schedule items." CONCOR shall not entertain any claim whatsoever in this respect.

Insurances (i.e, Contractor All risk policy & Workmen Compensation Policy) for works, persons and property shall be taken by the contractor at his own cost for the entire duration of the project.
