## Note:

- 1. Tender Document/sets shall be provided free of cost to Micro & Small enterprises (MSE's) registered with the listed agencies.
- 2. MSEs registered with the agencies for the item tendered will be exempted from payment of Earnest Money Deposit (EMD).



- 1. In case of e-Tendering, registration amount and tender processing fee will be applicable as per the requirement of e-tender.
- 2. (a) In case MSEs do not provide the below mentioned document, it should be made clear that such offer will not be entertained.
  - (b) The tender item is Non-split-able, hence participating MSEs quoting a price within price band of L1+15% shall not be applicable in this case.
  - (c) MSEs have started Udyog Aadhar Memorandum, an online registration system since 18th September, 2015 and all the MSEs who are having Udyog Aadhar Memorandum will be given all benefits available under Public Procurement Policy for MSEs order, 2012.
  - 3. MSEs who are interested in availing themselves of these benefits and preferential treatment, the MSEs will enclose with their offer the proof of their being MSE registered with any of the agencies mentioned in the notification of Ministry of MSE indicated below along with the bid:
  - i. District Industries Centers
  - ii. Khadi and Village Industries Commission
  - iii. Khadi and Village Industries Board
  - iv. Coir Board
  - v. National Small Industries Corporation
  - vi. Directorate of Handicraft and Handloom
  - vii. Any other body specified by Ministry of MSME
- The MSEs must also indicate the terminal validity date of their registration.
- 4. Failing (3) & (4) above, such offers will not be liable for consideration of benefits detailed in (2) above.
- 5. (A) Public Procurement (Preference to Make in India) order 2017:
  - In procurements of goods/services/works which are not divisible, and in procurement of services where the bid is evaluated on price alone, the following procedure shall be followed:
  - a) Among all qualified bids, the lowest bid will be termed as L1, if L1 is from a local supplier, the contract will be awarded to L1.
  - b) If L1 is not from a local supplier, the lowest bidder among the local suppliers, will be invited to match the L1 price subject to local supplier's quoted price falling within the margin of purchase preference (L1+20%),



- and the contract shall be awarded to such local supplier subject to matching the L1 price.
- c) In case such lowest eligible local supplier fails to match the L1 price, the local supplier with the next higher bid within the margin of purchase preference (L1+20%) shall be invited to match the L1 price and so on and contract shall be awarded accordingly. In case none of the local suppliers within the margin f purchase preference matches the L1 price, then the contract may be awarded to the L1 bidder.

The local supplier shall be required to provide a certificate (self-certification as per the enclosure-II supported by CA if the estimate cost of tender is <Rs. 10 Crore and if the estimate cost of tender is >Rs. 10 Crore Certificate from the statutory auditor or cost auditor of the company) stating that "the Item offered meets the minimum local content and shall give the details of the location(s) at which the local value addition is made".

## 5.(B) Policy on Startup:

In the subject tender no relaxation to be given to Startup(other than H&T, Survey tenders) on account of Prior turnover/Prior experience (certified by DIPP as per gazette notification dated 11/04/2018). Hence, Prior turnover/Prior experience (certified by DIPP as per gazette notification dated 11/04/2018) will be as it is and applicable accordingly.
