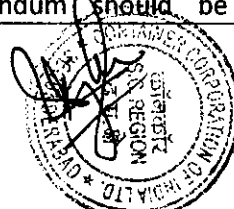





- II. The following addition is made as Note (iii) to Clause No.1.1 pertaining to the Experience in Chapter-IV (Page 19):-

(iii) No relaxation in prior experience / prior turnover and EMD is applicable for Startup, in this tender.


