ITI through e-payment. Bidders have to pay the Tender Processing Fee to ITI through e-payment at the time of submission of bid.

Note 1:

- (a) Tender Document shall be provided free of cost to Micro & Small Enterprises (MSEs) registered with the nominated agencies.
- (b) MSEs will be exempted from payment of Earnest Money (EMD).
- (c) In case of e-tendering, registration amount and tender processing fee will be applicable as per the requirement of e-tender.

- (d) In case MSEs do not provide the below mentioned document, it should be made clear that such offer will not be entertained.
- (e) Bidders quoting as MSEs (Micro or Small Enterprises) registered with relevant bodies like NSIC shall be exempted from the payment of Earnest Money Deposit (EMD) on submission of valid registration for the tendered item. However if any document submitted in support of getting benefit by MSEs at any moment of time even after award of contract is found to be false, the contract will be cancelled and action as per law will be initiated. Further it is clarified that no price preference shall be made available as splitting of contract for 20% of the tendered work is not feasible in this case.

In order to avail benefits/preferential treatment, the MSEs must be registered with any of the following:

- (i) District Industries Centers
- (ii) Khadi and Village Industries Commission
- (iii) Khadi and Village Industries Board
- (iv) Coir Board
- (v) National Small Industries Corporation
- (vi) Directorate of Handicraft and Handloom
- (vii) Any other body specified by Ministry of MSEs.
- (viii)MSEs have started Udyog Aadhar Memorandum (UAM), an online registration system since 18th September 2015 and all MSEs who are having Udyog Aadhar Memorandum will be given all benefits available under Public Procurement Policy for MSEs order. 2012

The MSEs must also indicate the terminal validity date of their registration (except UAM). In those cases where the MSEs are not able to provide the certificate with validity date of their registration, a self-declaration by the MSE (Party) on their letter head, confirming the validity of their registration can be accepted.

Note 2: Startup

- (i) Prior turnover/Prior experience will be relaxed by 5% for all Startup (certified by DIPP as per gazette notification dated 11.04.2018) subject to their meeting the quality and technical specifications specified in tender document.
- (ii) For availing the relaxation, bidder is required to submit requisite certificate towards Startup enterprise registration issued by Department of Industrial Policy and Promotion, Ministry of Commerce and the Certificate should be certified by the Chartered Accountant (not being an employee or a Director or not having any interest in the bidder's company/firm) and notary public with legible stamp.
- (ii) The Startup are also exempted from submission of EMD.
