### Tender Notice (E-TENDER MODE ONLY)

Online tender in Single Bid system are invited for **Establishing of Container Repair Facility to carry all Major and Minor Repairs of Damaged domestic Containers as per IICL specification at specified Container Terminals of Area-IV** only through e-tendering mode.

1. The bid document can only be downloaded from the website [www.tenderwizard.com](http://www.tenderwizard.com) and the intending bidders should submit the document sale price of Rs.1,000/- inclusive of all taxes and duties through e-payment at the time of making online request.
2. Complete tender papers duly shall be received online as per date and time mentioned below and may be opened in presence of the bidders or their authorized representatives.

ITI through e-payment. Bidders have to pay the Tender Processing Fee to ITI through e-payment.

**Note 2:**

1. Tender document shall be provided free of cost to Micro & Small Enterprises (MSE's) registered with the listed agencies.
2. MSEs registered with the agencies for the item tendered will be exempted from payment of Earnest Money Deposit (EMD).
3. MSEs who are interested in availing themselves of these benefits and preferential treatment, the MSEs will enclose with their offer the proof of their being MSE registered with any of the agencies mentioned in the notification of Ministry of MSME indicated below along with the bid:

  - ii. Khadi and Village Industries Commission
  - iii. Khadi and Village Industries Board
  - iv. Coir Board
  - v. National Small Industries Corporation
  - vi. Directorate of Handicraft and Handloom
  - vii. MSEs have started Udyog Aadhaar Memorandum (UAM), an online registration system since 18th September, 2015 and all MSEs who are having Udyog Aadhaar Memorandum will be given all benefits available under Public Procurement Policy for MSEs issued in order 2012 and amended from time to time.
  - viii. Any other body specified by Ministry of MSME, Government of India.

Such MSE bidders shall submit copy of valid Registration Certificate / Udyog Aadhaar (along with RDSO's approval) along with the bid, clearly including the tendered item in the registration certificate and the terminal validity date of registration. E-bids not accompanied by a valid Registration Certificate / Udyog Aadhaar shall be treated as e-bids from non-MSEs.

4. The MSEs must indicate the terminal validity date of their registration. In those cases where the MSEs are not able to provide the certificate with validity date of their registration, a self-declaration by the MSE (Party) on their letter head, confirming the validity of their registration can be accepted.
5. Failing (3) & (4) above, such offers will not be liable for consideration of benefits detailed under MSE.
