1. MICRO AND SMALL ENTERPRISES (MSEs) :-

- a) Micro & Small enterprises (MSE's) registered with the agencies mentioned below or having Udyog Aadhar Memorandum shall be exempted from payment of Earnest Money.
- b) MSEs who are interested in availing themselves of these benefits and preferential treatment, the MSEs will enclose with their offer the poof of their being MSE registered with any of the agencies mentioned in the notification of Ministry of MSME indicated below along with the bid.
 - (i) District Industries Centers
 - (ii) Khadi and Village Industries Commission
 - (iii) Khadi and Village Industries Board
 - (iv) Coir Board
 - (v) National Small Industries Corporation
 - (vi) Directorate of Handicraft and Handloom
 - (vii) Any other body specified by Ministry of MSME
- c) The MSEs must also indicate the terminal validity date of their registration.
- d) Failing (b) & (c) above, such offers will not be liable for consideration of benefits detailed in MSE notification of Government of India dated 23-03-12.
- e) The bidder shall submit UAM Certificate and MSME status as per the latest guidelines issued by Ministry of Micro, Small and Medium Enterprises.

2. Clause 2.1 (i) of Scope of Work, Chapter-3, Original Read as :

Container storage and Handling services at CONCOR terminals. For container storage, a free time of Date of arrival + 14 days on empty & loaded shall be provided, thereafter as per prevailing public tariff of TSC (Terminal Service Charges) at the CONCOR terminal shall be applicable on Icebattery containers.

For any Container Handling required, THC (Terminal Handling Charges) as per prevailing Public tariff at the CONCOR Terminal shall apply.

Clause 2.1 (i) of Scope of Work, Chapter-3, Amendment to read as: Container storage and Handling services at CONCOR terminals:

For container storage, a free time of Date of arrival + 14 days on empty & loaded shall be provided, thereafter as per prevailing public tariff of TSC (Terminal Service Charges) at the CONCOR terminal shall be applicable on Icebattery containers.

For any Container Handling required, THC (Terminal Handling Charges) shall be charged for single handling for each loading & unloading of Icebattery container as per prevailing Public tariff at the CONCOR Terminal.

3. Clause 2.1 (iii) of Scope of Work, Chapter-3, Original Read as :

Technical support services for operation and maintenance of Icebattery container including Plug-in facility for charging at origin and destination points at CONCOR terminals. CONCOR will collect Rs.2500 per trip for Technical Support Services provided plus Plug-in charges as per the prevailing Public tariff of that Terminal from Cargo provider for each container.

Clause 2.1 (iii) of Scope of Work, Chapter-3, Amendment to read as :

Technical support services for operation and maintenance of Icebattery container including Plug-in facility for charging at origin and destination points at CONCOR terminals. CONCOR will collect Rs.2500 per trip for Technical Support Services provided plus Plug-in charges equal to the cost of electricity consumed for charging of the Icebattery container plus (+) 10% mark up.

All other terms and conditions of aforesaid Tender document remain unchanged.
