1. About the Project

Container Corporation of India Limited (CONCOR) has constructed Multi Modal Logistics Park at Varnama, Taluka and District Vadodara (Gujarat) in 150 acre of land, aforesaid MMLP is first Gati Shakti Multi Modal Cargo Terminal (GCT) under Ministry of Railway GCT policy in Gujarat State, at aforesaid GCT we have 1(One) modern warehouse of 2,000 sqm area. CONCOR is interested to invite Expression of Interest (EOI) from interested parties for licensing out of warehouse space for the period of 06 (Six) years on as is where is basis.

2. Scope of Work

The amenities and infrastructures except building structure will be created by the bidder at its own cost as per their requirement. However, bidder could not change building structure. Electricity connection of appropriate power (Kw) and water connection up to the warehouse will be provided by the CONCOR. For increase in electricity load (Kw), CONCOR will arrange for its upgradation, however, bidder would be required to submit security deposit equal to the amount of expenditure for upgradation with CONCOR, which will be refunded after completion of license period.

All the tools, tackles, equipments, licenses, statutory compliances etc. will be deployed/borne by the bidder at their own cost.

Operation & Maintenance of the warehouse will be on account of the bidder for the entire license period.

3. Eligibility Criteria

- a) The bidder should be a registered firm/exporter/importer/forwarder/shipping line.
- b) The bidder has to quantify the Rail bound TEUs which will be generating because of the operations to be carried out in the aforesaid warehouse.

4. Reserve Price

Reserve price Rs.215 per sq meter/month with no escalation for first three (3) years. Thereafter there shall be an escalation of 5% annually.

The bidders must quote rates over and above the reserve price. The bidder should quote rates both in words and figures along with the signature & stamping by the authorized signatory of the firm on all the pages of EOI.

The bid shall be evaluated on the Highest quoted rate per Square meter per month.

In the event that two or more Bidders quoting the same rate, than bidder who has quoted the highest rail bound volume shall be selected for awarding the License of Warehouse Space on Long Term Basis at MMLP, Varnama.

The authority for acceptance/rejection of the EOI rates will rest with the Competent Authority of Container Corporation of India Ltd., New Delhi, who does not bind himself to accept the Highest or any other tender.

5. Contract Period

At the initial stage, warehouse space shall be given on license for a period of 06 years from the date of commencement of the contract. The license period will be extended on mutually agreed period, rates, terms & conditions.

6. Security Deposit

Successful bidder will deposit 3 months license fee toward refundable interest-free deposit before taking possession of the warehouse.
