1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

5. Past Project Experience

Bidders are requested to kindly visit the location (ICD/Agra, Uttar Pradesh) and also go through the brief description of work for better und erstanding, before submitting bids.

- (1) If the existing Contractor of CONCOR has submitted the tender for the same activity in the same facility , the existing contractors bid should necessarily be accompanied by a satisfactory performance report from the same terminal.
- (2) In case the bidder is working at any or one of CONCOR terminals in the same Area, his bid should neces sarily be accompanied by a satisfactory performance report from that/those terminal/s. In case, his bid is n ot accompanied with the above mentioned satisfactory performance report, it will not be considered.

(3) Shramik Kalyan Portal clause

The Contractor is to abide by the Provisions of payment of wages act & Minimum Wages Act in terms of cla use no 54 & 55 of Indian railways General Conditions of Contract. In Order to ensure the same, an applicati on has been developed and hosted on website www.shramikkalyan.indianrailways.gov.in. The Contractor s hall register his firm/company etc and upload requisite details of labour and their payment in this portal. T hese details shall be available in public domain. The Registration/updation of portal shall be done as under .

- a) Contractor shall apply for one time registration of his company/firm etc in the Shramik kalyan po rtal with requisite details subsequent to issue of LOI (Letter of Acceptance). Authorized representa tive of CONCOR shall approve the contractor's registration on the portal within 7 days of receipt of such request.
- b) Contractor once approved by any authorized representative of CONCOR, can create password wi th login ID (PAN No.) for subsequent use of portal for all LoAs issued in his favour.
- c) The contractor once registered on the portal shall provide details of his Letter of Acceptance (LO A), contract agreement on Shramik Kalyan portal within 15 days of issue of any LOA for approval of authorized representative of CONCOR. The authorized representative of CONCOR shall update (if required) and approve the details of LOA filled by contractor within 7 days of receipt of such request.
- d) After approval of LOA by the authorized representative of CONCOR contractor shall fill the salient details of contract labor engaged in the contract and ensure updating of each wage payment to the em on shramik kalyan portal on monthly basis.
- e) It shall be mandatory upon the contractor to ensure correct and prompt uploading of all salient d etails of engaged contractual labour and payments made thereof after each wage period. While pr ocessing payment of any "On Account Bill" or "Final Bill" or "release of Advances" or "Performance Guarantee/Security Deposit", contractor shall submit a certificate to the authorized representative of CONCOR that "I have uploaded the correct details of contract labours engaged in connection with this contract and payments made to them during the wage period in Railway's S hramikkalyan portal at 'www.shramikkalyan.indianrailways.gov.in'till______ Month_____Year.

(4) Penalty for delay in submission of SD

The successful bidder shall have to submit a Security Deposit (10% of the total contract value) within 15 (F ifteen) days from the date of issue of Letter of Intent (LOI) towards successful performance under this cont act. Extension of time for submission of SD beyond 15 (Fifteen) days and up to 30 days from the date of iss ue of LOI may be given by the Tender Accepting Authority. However, interest of 12% per annum shall be c harged for the delay beyond 15 (Fifteen) days, i.e. from 16 th day after the date of issue of LOI. Further, if t he 30 th day happens to be a declared holiday in the concerned office of the CONCOR, submission of SD c an be accepted on the next working day. In all other cases, if the Contractor fails to submit the requisite S D even after 30 days from the date of issue of LOI, the contract is liable to be terminated. In case contract i s terminated, CONCOR shall be entitled to forfeit Earnest Money Deposit and other dues payable against t hat contract. In case a tenderer has not submitted Earnest Money Deposit on the strength of their registra tion as a Micro & Small Enterprises (MSEs) registered with the nominated agencies or a Startup recognized by Department of Industrial Policy and Promotion (DIPP) under Ministry of Commerce and Industry, concern ed office or DIPP as the case may be shall be informed to this effect. The failed Contractor shall be debarre d from participating in re-tender for that work.

(5) Escalation/De-escalation:

The vehicles supplied to CONCOR shall normally be petrol/diesel/CNG operated vehicles. The CONCOR res erves the right to increase/decrease rate depending upon the type of fuel being used as per the prescribed formula as indicated below:

- (i) The revision of the rates due to increase in the petrol/diesel/CNG prices shall be considered by CONCOR if the increase/decrease announced by the Government of India is more than 15%. The increase/decrease beyond 15% (including piecemeal increase/decrease), the rates shall be increased/decreased by $1/4^{th}$ of the percentage increase/decrease in the fuel price. The variation in rates shall be affected from the 1^{st} day of the following month in which the variation in prices of fuel takes place as indicated above.
- (ii) The specified benchmark of increase or decrease of 15% is on the rates of diesel/CNG/Petrol on the dat e of submission of tender.
- (iii) The rates of diesel/CNG/petrol as on date of previous escalation will form base for calculation of subseq uent 15% variation for next escalation.

(6) Time limit for submission of bills

- (i) The contractor shall make a claim for the services rendered under this contract to CONCOR within Four months of such service. If he does not prefer claim within the said period he shall be deemed to have waiv ed his right in the respect thereof and shall not be entitled to any payment on account thereof. Neverthele ss, the accepting authority on written request can waive off this limitation and allow late submission of bill s if the reasons for delay are found convincing and reasonable.
- (ii) No claim in respect of under payment to the contractor shall be considered valid or entertained unless a claim in writing is made thereof within (4) four months from the date on which payment of the original cl aim thereto was made. Any claim for such under payment not received within stipulated four months perio d, shall be liable to be summarily rejected by CONCOR. Nevertheless, the accepting authority on written re quest can waive off this limitation and allow late submission of bills if the reasons for delay are found convincing and reasonable.

(iii) However, in case of any specific issue over which the contractor had not billed for any particular activit y, the same can be allowed for payment, subject to the prior approval of Tender Accepting Authority, notwi thstanding what has been laid down in the Clause on Payment. The decision of the Tender Accepting Authority shall be final and binding on the contractor.

Interpretation/General Clause - Doubts, if any, about the interpretation of any of the clauses in this ten der, meanings of words, terms, specifications, operations or instructions, or as to the quality of workmansh ip or performance shall be referred to the Tender Accepting Authority (TAA) of CONCOR, whose decision in the matter shall be final. Similarly any difficulty in implementing the contract can be resolved by referring the matter to the Tender Accepting Authority, who can amend the CONCOR's condition/clause of contract, if required.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्तें</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition

specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
