Sub: - Observance of Vigilance Awareness Week, 2011 by CONCOR.

In pursuance of CVC's decision to observe Vigilance Awareness Week every year, the Vigilance Awareness Week for this year will be observed from 31st October to 5th November, 2011. This year the theme of observing Vigilance Awareness Week is "*Participative vigilance*". Copy of the letter of Secretary, CVC dated 12/9/2011 is enclosed for guidance. The following activities are to be organized during the Vigilance Awareness Week.

1. The observance of the Vigilance Awareness week should commence with the pledge on 31st October, at 11.00 a.m. The pledge will be administered by the Head of the Office (Regional Offices, ICDs, CFSs etc.). A copy of the pledge is enclosed.
2. Each regional office and terminal should organize various activities on the main theme "*Participative Vigilance*" involving officers, staff, customers, contractors and stake holders including group discussions/interactive sessions / workshops /competitions. During this period special attention may also be paid on the quality of facilities being provided to customers/stakeholders in the terminals and measures to enhance customer satisfaction..
3. On 31st October, 2011, at 11.00 a.m. a workshop will be organized at C.O. All EDs/GGMs/SGMs of Corporate Office are nominated to attend the workshop.
4. On 1st November, 2011, at 10.30 a.m. Vigilance Workshop will be held in Northern Region and MD/CONCOR has kindly agreed to inaugurate the workshop, which would also be addressed by Advisor (Vigilance)/ Railway Board. All Terminal Managers and Asst Supervisors and above of Northern Region are advised to attend the workshop.
5. On 2nd November, 2011, at 11.00 a.m. Vigilance workshop will be held in Western Region and MD/CONCOR has kindly agreed to inaugurate the workshop. In the workshop Business Associates, H&T/Security/Survey contractors, CHA and important customers will participate. In addition, TMs, Accounts / C&O / Engg staff of the regional office will also participate..
6. On 4th November, 2011, at 11.00 a.m. a training programme will be organized at C.O. in which officials up to the level of Sr. Supervisors of NR and NCR will participate.
7. Competition on paragraph writing on "*Participative Vigilance*" and slogan writing highlighting the same in Hindi / English shall be organized in Corporate

Office, Regional Offices, ICDs, CFSs on 03.11.11. The paragraph should not exceed 400 words. A cash award of Rs.3000/-, Rs.2,500/- and Rs.2000/- for paragraph writing and Rs.1,500/-, Rs.1000/- and Rs.750/- for slogan writing will be given for 1st, 2nd and 3rd entries selected from each activity. Papers submitted for the competition may be sent to Vigilance Division for evaluation.

All regional Heads / Terminal In-charges are expected to ensure successful celebration of observance of Vigilance Awareness Period as per schedule. All EDs/CGMs and their officers are requested to visit as many terminals as possible to participate in activities related to vigilance awareness.
